Chief Thomas handed out the July incident report...Mick gave him the speed sign reports....Chief Thomas read to the children at Story Time....he also mentioned that 37 charges were filed against an individual as a result of an incident on South Main Street.

Ann Gillespie had paperwork she needed help with to fill out for a variance hearing...

Council told her to contact Keith Hunnings ....

Hall Committee – August 9th – Back to School Bash (Story Time)....Air conditioning

quote from Abe Service Company - \$ 35,787.00...price does not include electrical costs....decision will be made at September's meeting....Sound-Soak – Don has contacted someone who will hang it...the Borough needs to purchase the material....the hall is being used, every Wednesday, to pass out 'power packs' (food boxes) for those in need....

Street Committee - speed sign info passed out....renewal quote for the new solar (cloud) speed signs is \$ 3,000, due January 12, 2024...whether or not to renew the cloud was tabled till September's meeting......There are holes beside (2) storm drains on Hedgewick Lane which need to be fixed...suggestion was made to check the rest of the storm drains in the Borough.....

DE Gemmill got in contact with Don about putting up street signs....the cost is \$ 56.00 per hour,

consisting of a (2) man crew. They would work 8-10 hours a day...The Boro has all the material

(10) foot poles & new signs, etc)...they would just install the new signs....Kim Godfrey made a

motion, seconded by Victor Dodson, to hire DE Gemmill for (1) day to see how many signs they can install. Motion carried. Victor Dodson made a motion, seconded by Mick Regel, to have Pro-Lawn

spray the curbs/sidewalks again. Motion carried....Kim asked if Pro-Lawn could use all natural spray material'; when Don contacts Pro-Lawn he will ask.....

Playground Committee - Fire Cracker tournament was held last Thursday, Friday, and Saturday...

Our baseball field was the only dirt field used...very good reports were received about the shape and maintenance of the field....Ed Gobat will be resigning from the committee the end of this year;

People are needed to volunteer to be on the committee and handle all the bookings, concession stand,

etc. that Ed did for the last number of years.....

Ordinance Committee - nothing to report

Community Pride Committee – Trunk or Treat is October 28th....November 11th is the Veterans' Day breakfast....December 2nd is the tree lighting...December 9th is Breakfast with Santa...December 23rd if the Christmas decorating contest....

Human Resource's Committee - nothing to report

Chair's Report – Don reported that he attended the Community Pride Committee meeting, EYARC meeting, and Fire Company meeting....Don will schedule a meeting in October, with all the aforementioned groups, for all to hand in a schedule of events, each organization plans to hold, for the rest of 2023 and all of 2024.
