**ORDINANCE NO.: 2011 - 5**

**AN ORDINANCE ESTABLISHING AMENDED COMPENSATION  
RATES FOR BOROUGH COUNCIL MEMBERS AND THE  
MAYOR**

WHEREAS, Section 1001 of the Pennsylvania Borough Code (53 P.S. §46001), as amended, authorizes Borough Council to establish compensation of Borough Council Members, by Ordinance adopted from time to time, and

WHEREAS, Section 1024 of the Pennsylvania Borough Code (53 P.S. §46024), as amended, authorizes Borough Council to establish compensation of the Mayor, by ordinance adopted from time to time; and

WHEREAS, on January 2, 1968, the Borough Council adopted Ordinance 68-2 fixing the compensation of the Borough Council Members and the Mayor; and

WHEREAS, Ordinance 68-2 has been amended several times since January 2, 1968; and

WHEREAS, Borough Council has determined a need to increase the current compensation paid to Borough Council Members and the Mayor.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED and it is hereby ordained and enacted by the Borough Council of East Prospect, York County, Pennsylvania, as follows:

Section 1. Effective January 1, 2012, all Council Members for the Borough of East Prospect shall receive compensation in the amount of One Hundred Dollars (\$100.00) per regular or special Borough Council meeting attended payable in quarterly installments, and the President of Borough Council shall receive an additional Fifteen Dollars (\$15.00) for a total of One Hundred Fifteen Dollars (\$115.00) per regular or special Borough Council meeting attended payable in quarterly installments. Compensation shall be paid for a maximum of fifteen (15) regular or special Borough Council meetings attended per year.

Section 2. Effective January 1, 2012, the Mayor of the Borough of East Prospect shall receive annual compensation in the amount of Two Thousand Five Hundred Dollars (\$2,500.00) payable in equal quarterly installments of Six Hundred Twenty Five Dollars (\$625.00) per quarter.

Section 3. All prior ordinances to the extent that are inconsistent herewith are hereby repealed.

Section 4. This Ordinance shall become effective on the dates provided for herein.
