ORDINANCE NO. 2005-12

AN ORDINANCE AMENDING ORDINANCE NO. 75-2 AND ORDINANCE NO. 1991-3 BY CHANGING THE TIMES REFUSE AND RECYCLING ITEMS MAY BE PLACED AT COLLECTION POINTS, AND MODIFYING THE PENALTIES FOR VIOLATION OF SAID ORDINANCES.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of East Prospect, York County, Pennsylvania as follows:

- Section IV of Ordinance No. 75-2, entitled "Refuse Ordinance," is hereby amended by the addition of a new subsection entitled "Placement and Removal at Collection Points":
 - (a) Placement at the collection point shall not be earlier than 12:00 Noon, Prevailing Time, on the day immediately preceding a scheduled collection date, nor later than 6:00 A.M., Prevailing Time, on the scheduled collection date.
 - (b) Removal of empty refuse containers shall be removed from the place of collection no later than 8:00 P.M. on the day of collection after collection.
- Section 2. Section IX of Ordinance No. 75-2, entitled "Penalties," is hereby amended to read as follows:
 - (a) Any person who shall violate any provision of this Ordinance shall, upon conviction, be sentenced to pay a fine of not less than Twenty-five (\$25.00) Dollars nor more than Six Hundred (\$600.00) Dollars, plus the cost of prosecution, and in default of payment thereof, shall be imprisoned for not more than thirty (30) days.
- Section 3. Subparagraph (ii) of subsection (c) of Section IV of Ordinance No. 1991-3, entitled "Separation and Disposal of Recyclable Materials Generated at Residences," is hereby amended as follows:
 - (ii) Placement at the collection points shall not be earlier than 12:00 Noon, Prevailing Time, on a day immediately preceding a scheduled collection day, nor later than 6:00 A.M., Prevailing Time, on the scheduled collection date.
- Section 4. Subsection (c) of Section IV of Ordinance No. 1991-3, entitled "Separation and Disposal of Recyclable Materials Generated at Residences," is hereby amended by adding a new subparagraph (iii) as follows:

- (iii) Removal of empty containers at the collection point shall be no later than 8:00 P.M. on the day of collection after collection.
- Section 5. Nothing contained in this Ordinance shall be construed to interfere with or in any way modify the provisions of any existing contract, which is consistent with the laws of the Commonwealth of Pennsylvania and in force in the Borough on the effective date of this Ordinance.
- <u>Section</u> 6. Any ordinance or portion thereof, which is inconsistent herewith, is hereby repealed to the extent of such inconsistency.

<u>Section 7</u>. This Ordinance shall become effective five (5) days after enactment.
