ORDINANCE NO. 2014- #2

**AN ORDINANCE OF THE BOROUGH OF EAST PROSPECT,
YORK COUNTY, PENNSYLVANIA, ADOPTING AN
ORDINANCE, ENTITLED "STORMWATER MANAGEMENT,"
REGULATING THE MANAGEMENT OF STORMWATER
WITHIN THE BOROUGH OF EAST PROSPECT, YORK
COUNTY, PENNSYLVANIA.**

NOW, THEREFORE, BE IT SO ENACTED AND ORDAINED, by the Borough Council of East Prospect Borough, York County, Pennsylvania, by the authority of the same, as follows:

Section 1. The attached Ordinance entitled "STORMWATER MANAGEMENT," is hereby adopted by the Borough of East Prospect, York County, Pennsylvania, including the Appendices thereto and Tables, as set forth in the same. The attached Ordinance is incorporated as if set forth more fully herein.

Section 2. Severability.

It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid. In such case, all provisions of this Ordinance that were not declared invalid shall continue to be separately and fully effective. Borough Council hereby declares that it would have passed all other parts of this Ordinance, without including any part declared invalid, if it had advance knowledge that such part would be declared invalid.

Section 3. Procedural Defects in Enactment.

Allegations that this Ordinance or any amendment was enacted in a procedurally defective manner shall be appealed as provided in Pennsylvania law.

Section 4. Repealer.

Any provisions of any Borough ordinances or parts thereof that are inconsistent or incompatible herewith are repealed to the extent of such inconsistency or incompatibility. This Repealer clause shall only repeal Borough ordinances or parts thereof that were adopted prior to this Ordinance and that are clearly in direct conflict with this Ordinance.

Section 5. Enactment.

This Ordinance shall become effective five (5) days after enactment.
