

ORDINANCE NO. 69-5

REGULATING TRAFFIC IN, AND CERTAIN USES OF THE STREETS, HIGHWAYS,  
AND AVENUES OF THE BOROUGH OF EAST PROSPECT.

BE IT ENACTED AND ORDAINED by the Borough of East Prospect, and it is hereby enacted and ordained by authority of the same, that it shall be unlawful for any person, firm or corporation to violate or fail to comply with the following regulations pertaining to traffic in, and certain uses of the streets, highways and avenues of the Borough of East Prospect, under the penalty hereinafter provided.

SECTION I. The definitions contained in the Vehicle Code shall apply to this ordinance.

SECTION II. When parking, vehicles shall be drawn up to the right hand curb and stopped no more than six inches from the curb and parallel thereto, unless lines, arrows, or other directions are applicable to the particular place. To conserve parking space, each vehicle shall be driven to within four feet of any other vehicle parked in the immediate vicinity, or to the limit of the position wherein parking is permitted.

SECTION III. In addition to the other provisions herein, no vehicle shall be parked opposite a curb painted yellow by the Borough or where signs are placed and maintained by the Borough indicating that parking is prohibited.

SECTION IV. No person shall place any signs or paint any curb to regulate traffic in the streets, avenues, or highways, except under proper authority and after approval by the Borough Council.

SECTION V. In order to facilitate the flow of traffic in the Borough, the following no-parking areas are hereby designated and established:

- (1) No vehicle shall be parked on the north side of West Maple Street beginning at the square and extending to Lemon Avenue.

- (2) No vehicle shall be parked on the south side of West Maple Street from Lemon Avenue to the Borough limits.
- (3) No vehicle shall be parked on the north side of East Maple Street from the square to the Borough limits.
- (4) No vehicle shall be parked on the east side of North Main Street from the square to North Main Street Extended, and no vehicle shall be parked on the north side of North Main Street Extended.
- (5) No vehicle shall be parked on the west side of South Main Street from the square to the Borough limits.
- (6) No vehicle shall be parked on the south side of Ridge Avenue to Lemon Street.
- (7) No vehicle shall be parked in any of the avenues of the Borough.

SECTION VI. Cherry Avenue, running eastwardly from Middle Avenue to South Princess Avenue, is hereby declared to be a one-way thoroughfare with its entrance at Middle Avenue and its exit at South Princess Avenue.

SECTION VII. All persons violating the provisions of this ordinance shall be subject to a fine of not more than Twenty-Five Dollars (\$25.00) for each offense, and each daily occurrence of the same offense shall be considered a new offense. In default of payment of the fine, the offender may be imprisoned for a period not exceeding five days. Said fine or penalty shall be collected by summary conviction before the Mayor or any Justice of the Peace as like fines and penalties are now collected by law.
