ORDINANCE NO.: 2011- \

AN ORDINANCE RESTATING THE COMPENSATION OF THE TAX COLLECTOR OF THE BOROUGH OF EAST PROSPECT AND AUTHORIZING THE TAX COLLECTOR TO COLLECT CERTAIN FEES ASSOCIATED WITH THE REIMBURSEMENT OF EXPENSES

WHEREAS, Section 35 of the Local Tax Collection Law (72 P.S. 5511.35) as amended, authorizes the Borough Council to determine the compensation of its Tax Collector for the collection of taxes; and

WHEREAS, the Borough Council is further authorized to set fees for reimbursement of expenses of the Tax Collector; and

WHEREAS, the Borough Council had previously set the compensation of the Tax Collector at Five (5.00%) percent on all collections of taxes by the Tax Collector, which compensation is the maximum permitted by law.

WHEREAS, the Borough Council of East Prospect Borough desires to restate such compensation and fees associated with expenses.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of East Prospect, York County, Pennsylvania, as follows:

- <u>Section 1</u>. The compensation of the Tax Collector is hereby restated as Five (5.00%) percent on all collections of taxes by the Tax Collector.
- <u>Section 2</u>. The Tax Collector is hereby authorized to collect the following fees associated with the reimbursement of expenses.
 - a. The Tax Collector is authorized to provide tax certifications upon request by the public and further is authorized to charge for his or her expenses in connection therewith and retain for reimbursement of such expenses a fee of up to Twenty-Five (\$25.00) Dollars per certification.
 - b. The Tax Collector is authorized to provide, upon request, and is further authorized to charge no more than his or her expenses in connection therewith and retain for reimbursement of such expenses, fees of up to the following:
 - 1. Duplicate or memo bills: \$10.00 per bill requested.
 - 2. Duplicate receipts: \$1.00 per receipt requested.

c.	The Tax Collector is authorized to charge a fee of up to Fifty (\$50.00) Dolle each check returned due to non-sufficient funds.	ars for
